

Sealed tenders should be submitted by inserting in the tender box placed at the room of Executive Engineer (Agril. Engg.), Directorate of Agriculture (Crop Husbandry), Aizawl on or before the 30th Dec, 2014 till 11:00 a.m. and the same will be opened on the same date at 12:00 noon. Detailed documents can be obtained from the office of Executive Engineer (Agril. Engg.) Directorate of Agriculture (Crop Husbandry), Aizawl on payment of required amount for each item in cash (Non refundable) as mentioned in the terms and conditions during office hours on all working days. TERMS AND CONDITIONS FOR SUPPLY OF FARM MACHINERIES AND IMPLEMENTS

TENDER NO EE/AGRI/2014-15/02 : dt.27.11.2014

1. Tenders are invited only from registered and reputed manufacturers or authorized dealers/distributors of the tendered items mentioned in the annexure I.
2. If the bidder is manufacturer, a photo copy of Manufacturer Statutory Registration Certificate attested by Gazetted Officer of either Central or State Govt. or Notary should be enclosed along with tender documents.
3. If the bidder is authorized dealers/distributor, a photo copy of authorization certificate for dealership/distributorship issued by principal manufacturer attested by Gazetted Officer of either Central or State Govt. or Notary should be enclosed along with tender documents.
4. Tribal Bidders should enclose a copy of Tribal Certificate attested by Gazetted Officer of either Central or State Govt. or Notary.
5. Tenders should be submitted in computer typed as per FORMAT for each item at annexure II to XII. All the necessary supporting documents indicated in the FORMAT for each item should be enclosed and the enclosed photo copies of documents should be attested by Gazetted Officer of either Central or State Govt. or Notary.
6. Cost of tender FORMAT should be deposited as mention in annexure I.
7. As mentioned in annexure I, for each offered item separate Earnest Money Deposit in the form of Deposit at Call in favour of the Director, Department of Agriculture (Crop Husbandry), Government of Mizoram, Aizawl issued by any Nationalized/Scheduled Bank recognized by the R.B.I.
8. Tender for each offered item listed in annexure I should be kept in separate cover / envelop by super scribing as TENDERS NO: EE/AGRI/2014-15/02 “TENDER FOR SUPPLY OF (name of machineries or implements to be written)” and address it to the Director of Agriculture (Crop Husbandry), Mizoram, Aizawl and name & address of bidders should also be clearly written at the left bottom corner of the envelope. The envelope / cover should be sealed either with sealing wax or cello-tape.
9. Items offered except Sl No 10 (Gur Boiling Pan) of annexure I, should have relevant test certificate from the Authorized Govt. Institute as per guideline of Ministry of Agriculture and Co-operation, Govt. of India or I.S.I. marking certificate. Copies of relevant certificate duly attested by gazetted officer or notary from the concerned Authorized Government Institute should be enclosed.
10. Specifications of any bid item mentioned in the tenders should conform to the technical/performance reports enclosed. In case of Gur Boiling Pan, specifications should be as per mentioned at Sl No 10 of annexure I.

11. Additional specifications & features if any which the bidder likes to highlight may be mentioned in the bidding document. Leaflets/pamphlets/literatures showing dimensions, specifications, pictures, etc., issued by manufacturer should be enclosed for each model.
12. Photo copy of VAT Registration certificate and up-to-date VAT Clearance Certificate should be submitted. Bid items should be listed items in VAT registration.
13. Offered farm equipments/implements/machineries should have warranty for a period of not less than 6 months from the date of delivery to the farmer(s)/farmer.
14. Bidders should have after sales service centre and spare parts should be available in state capital Aizawl and outlet/showroom at all district capitals.
15. If possible, wherein the participant or their authorized representative may also remain present at the time of opening.
16. State Purchase Advisory Board under Agriculture Department, Government of Mizoram will evaluate the tenders.
17. Price of the each individual model of the offered Farm machineries/equipments shall be included with the cost of all accessories & tools (name of accessories & tools with quantity should be mentioned specifically). Bidders should quote their rates in both figures and words F.O.R., (as mentioned in the tender form) inclusive of all taxes and all other charges.
18. The price offered by the bidder shall remain constant for 1(one) year from the date of opening the tenders and if required validity period can be extended for another six months if agreed by the Administrative Department.
19. Machineries/implements/equipments are to be made available by the supplier as per choice of brand & model by farmer/farmers. Delivery of farm machineries shall be made in the prescribed period from the date of intimation to the supplier, failing which supply order issuing authority shall cancel the supply order with intimation to the Director, Agriculture (Crop Husbandry), Government of Mizoram who will be at liberty to de-list the manufacturer from the panel of supplier with forfeiture of E.M.D. with the approval of the administrative department.
20. The companies/manufacturers/dealers whose product or performance regarding after sale services was not found satisfactory in the past or whose quality/specification of the product is in dispute may not be included in the short list.
21. Department/farmer(s) may order for testing/verification of performance of the equipment before receipt/ delivery. The testing will be done at the cost of the supplier. The department/ farmer(s) may reject the offered goods/equipments, if not found satisfactory in any manners.

22. Any officer of the Department, authorized by the Government, may visit the factory of the manufacturer prior to enlisting bidder in the approved short list or any time even after enlisting in the short list. Any deviation found during the factory visit may lead to de-list the said manufacturer from the approved list.
23. The department reserves the right to only reject all the offers received from the participants/bidder and to cancel the tender process at any time without showing any reason to the affected Bidder or Bidders.
24. Each and every page of the tender has to be signed and stamped by the bidder. Each page of all the submitted documents should be page marked clearly with total number of submitted pages.
25. **Mode of Implementation of the schemes**
 - a) Farm machineries and implements will be procured by farmer(s) as per their choice, with assistance to be provided by the Department, among the brands and models to be empanelled or selected by the Department from the participants of this Tender Notice.
 - b) Selected farmer/farmers will submit their share based on the rates in their respective district capital in the form of Bank Draft/cash to the office of the respective District Agriculture Officers/concerned Officers in the Department's Directorate Office along with name of machinery/implement mentioning preferred Brand/Model from empanelled list. On receipt of the name of brand/model chosen by the farmer/ farmers and farmers contribution, Department will place supply orders to the selected firms with farmers' contribution as advance payment.
 - c) Suppliers should deliver ordered items to the farmers in the presence of district officials at their respective district capitals. If the suppliers do not have any sub-agent/outlet in the district capitals other than Aizawl, they should deliver materials to the beneficiaries at any place in the district capital and time arranged by the departments/district officials. Farmers in the districts other than Aizawl may also purchase their chosen items from dealers' outlets at Aizawl with the approved rates at Aizawl as per their convenience.
 - d) If the beneficiaries insist demonstration on operation / performance of items to be purchased, supplier should do to satisfy their customers.
 - e) 5% of cost of supply /supplies will be detained from subsidy portion as security deposit for period of 6 (six) months from date of release of bill and will be refunded without any interest to the supplier.
 - f) After delivery of the materials to the farmers and receiving documents like delivery Challan, receipt for farmers' contribution, etc., showing that farmer/farmers had actually received the materials, the Government's share based on the operational guidelines / approved annual action plan of the schemes will be released to the suppliers.

26. Original documents of all the attested copies of documents should be brought at the time of opening of tenders for clarification of any suspected papers.
27. The offered price shall be valid for one year from the date of this tender notice or publication of next year's approved price, whichever is earlier. Beneficiaries have right to negotiate offered price. Supplier's offer of discount on approved price for the benefit of beneficiaries will be entertained.
28. Sample(s) for item nos 8 & 11 of annexure I should be submitted at the time of opening of tenders and should be labeled with the name and address of bidders.
29. Post tender offer and conditional offer will not be entertained.
30. In case of any legal disputes and litigations arising out of this quotations notice, the matter will be heard and settled in the court of law at Aizawl only.
31. The undersigned is not bound to accept the lowest rate or any of the quotations reserved right to accept or reject any quotation without assigning any reason thereof
32. Disagreement/failure of any or all of the required conditions mentioned above may entail disqualification of the tender.
