Terms of Reference:

- 1) Mobilization, identification, selection and monitoring of reliable cooperative societies/ FPOs/ FPCs/PACS/SHGs/Farmer Interest Groups for aggregation and marketing/sale of notified crops under the Handholding Scheme in the district.
- 2) Identification of government buildings, warehouses, godowns, market sheds and other infrastructure available in the district for collection/grading/aggregation of notified crops.
- 3) Identification of suitable land for construction of post-harvest infrastructure facilities in the production clusters of the districts.

- 4) Capacity building of identified cooperative societies/FPOs/FPCs/PACS/SHGs/Farmer Interest Groups regarding quality control, weighment/packaging, book-keeping, auctioning, agricultural marketing, etc. and facilitating them to federate to higher levels.
- 5) Collection and sharing of market information and market intelligence.
- 6) Supervision of activities of the cooperative societies/ FPOs/ FPCs/PACS/SHGs/Farmer Interest Groups etc. as per the guidelines and SOP prescribed by MAMB.
- 7) Maintenance of record of real-time data on crop production and sales within their jurisdiction and submission of periodic reports to the Mizoram Agricultural Marketing Board (MAMB).
- 8) To perform any other roles relating to agricultural marketing as may be assigned by the Government of Mizoram/MAMB.
